

The meeting was called to order by Charles at 7:30 PM.

Agenda included:

Opening : Charles discussed the need to act as a team and the need to work with majority rule.

Pressing Business

Music : There have been complaints about the music. It was decided that there would be votes at the next general meeting:

Current Opportunity

Housekeeping

The board decided that we would continue with the tradition of having the 2012 COC dinner at Lighthouse Point Yacht Club. A check to reserve the room will be issued the evening of the 2011 COC dinner.

Calendar 2011

The calendar was completed and agreed upon for the months of January and February. It will be discussed more fully at the next board meeting.

Other Business Discussed

- A recommendation was made that 50/50 profits be earmarked for captains gifts.
- The board discussed having more activities with Gulfstream and Hillsborough sailing clubs.
- The board agreed to allow Cynthia to set up a virtual store at cafepress.com so that members can order official club items from them during this year.
- It was agreed that all board members would read the club rules in the pink book for discussion at the next board meeting.

Among the new things planned for this year, will be an additional formal event, a captains ball followed by a captains sail June 18th and 19th. Marie and her committee have been looking at options, prices and places for the holiday party. All of the Charter boats are too expensive. Several other options were discussed. All cost significantly more than was paid last year. The committee will continue to look. It was also discussed that a pre-arranged set up and clean up committee be arranged for each club sponsored party so that hosts and hostesses will not find themselves with a mess.

It was discussed that it would be a good idea if all new members attend mini class on sailing safety and etiquette before being placed on any boats.


